



OPERATIONAL DATA – JULY 2024

BRISANET HAS ADDED MORE THAN 29,000 MOBILE CUSTOMERS AND 11,000 ON FTTH.

Pereiro, Ceará, August 15, 2024 – Brisanet Participações S.A. (“Company” or “Brisanet”) (B3: BRIT3) communicates to its shareholders and the market in general, the operational data for the month of July.

At the end of **July 2024**, Brisanet served **1,371,792 customers** in all 9 states in the Northeast region, passing through 7.0 million homes in 158 cities. During the period, we highlight the **organic growth of 11 thousand HCs**.

Additionally, Brisanet also operates through its franchisor, Agility Telecom. The brand is represented by 67 franchisees who operate in smaller cities or rural districts in the region serving 171,924 customers.

Considering both bases, the Company **serves more than 1.5 million fixed broadband customers** throughout the Northeast region.

The growth of the mobile base in the period was 29,280 customers, reaching 157,684 active chips on July 31, 2024. The Company ended the month of July with 7.1 mm of inhabitants covered by its mobile infrastructure.
