## NOTICE TO THE MARKET

## **GUIDELINES - INCOME TAX REPORTS FOR 2024**

**Brisanet Serviços de Telecomunicações S.A.** ("Company") informs its shareholders and the market in general that, according to the notice to the market published on September 16, 2024, the bookkeeping services were transferred from **Itaú Corretora de Valores S.A.** ("Old Bookkeeper") to **BTG Pactual Serviços Financeiros S.A.** DTVM ("New Bookkeeper"). As a result of this change, shareholders who maintained their position in the Company throughout the year should receive two Income Tax Reports, one for the period before and one for the period after the transfer, both for income tax declaration purposes.

Below are further guidelines and important information for accessing the Income Tax Reports:

## I. Current Bookkeeper - BTG Pactual Serviços Financeiros S.A. DTVM:

The Income Tax Reports will be made available exclusively digitally through the <u>Investor Portal</u>. For investors who do not yet have access to the platform, it can be requested through the <u>"First Access?"</u> field available on the Portal's home screen, following the step-by-step instructions described in the <u>manual</u>.

**II. Former Bookkeeper - Itaú Corretora de Valores S.A.:** To obtain the Income Tax Report for the period prior to the transfer, the shareholder must contact the Former Bookkeeper through the channels below:

To obtain your income tax statement, access **Banco Itaú's digital** correspondence portal.

If this is your first time, follow the steps below:

- At the address (<u>https://correspondenciasdigitais.itau.com.br/</u>), click on First Access;
- 2. Enter your CPF and date of birth (Individuals) or CNPJ and date of foundation (Legal Entities);
- 3. Choose the option to verify your identity (phone number or e-mail address). If you can't find your phone number or email address, call our Call Center 0800 720 0223;





- 4. Enter the code you received by email and/or telephone and create your personal password;
- 5. Done, now just enter your CPF/CNPJ and the new registered password to access your documents.

Finally, investors are responsible for keeping their registration data duly updated with their custody agents, as this information is considered for reporting and tax purposes.
