# MATERIAL FACT DISCLOSURE OF OPERATIONAL PROJECTIONS (GUIDANCE)

**BRISANET PARTICIPAÇÕES S.A.** (B3: BRIT3) ("Company", "Brisanet"), in compliance with the provisions of Resolution of the Securities and Exchange Commission ("CVM") No. 44, of August 23, 2021 and Law No. 6,404, of December 15, 1976, as amended, informs its shareholders and the market in general that: (i) it will discontinue its operational projections (guidance) in reference to the Relevant Fact, disclosed on April 26, 2023, relating to homes passed and homes connected, for the reasons presented below; and (ii) will publish operational projections (guidance) of the number of municipalities with mobile coverage and their respective covered populations, as per the following terms.

#### 1 - DISCONTINUITY OF DISCLOSURE

#### 1.1 PROJECTION FOR HOMES PASSED ("HPs"):

Year	Projection (Until 12/31/23)	Actual (Until 11/30/23)	
2023	7.1 million HPs	7.0 million HPs	

By the end of November 2023, we reached **7.0 million HPs**.

Considering that a household has an average of 3 inhabitants, we reached a population of 21 mm of inhabitants with the FTTH (Fiber to the Home) fixed broadband infrastructure.

### 1.2 PROJECTION FOR HOMES CONNECTED ("HCs"):

2023	1.3 million HCs	1.28 million HCs

By the end of November 2023, we reached **1.28 million HCs**.

As of the third quarter of 2023, the Company has prioritized investments in mobile infrastructure, which includes the future sale of fixed broadband through FWA (Fixed Wireless Access


Therefore, the Company's management decided to discontinue the disclosure of the operational projections (guidance) above, essentially due to the current strategic alignment with the Company entering the mobile segment. HCs tend to continue growing given the HP infrastructure implemented and ready to be occupied.

Seeking to highlight the evolution and pace of the Company's expansion in its mobile segment, we confirm that from this disclosure, the Company announces that it will publish, quarterly (with each release of quarterly results), the operational projection of the number of municipalities that have the Company's mobile coverage and their respective covered populations, in addition to the number of inhabitants covered by our FTTH infrastructure, in the same area.
